**UTAH STOCKDOG ASSOCIATION
WAIVER AND RELEASE OF LIABILITY and ASSUMPTION OF RISK**

In consideration of the Utah Stockdog Association allowing me, the undersigned, to participate in the Utah Stockdog Association Sheepdog Trial, I, for myself, and on behalf of my spouse, children, heirs and next of kin and any legal and personal representatives, executors, administrators, successors, and assigns, acknowledge and agree to the following (referred to as the "Agreement"):

1. DEFINITIONS:

- a. "Event" or "Activity" refers to the Utah Stockdog Sheepdog 2020 Fall-ing for Ewe Trial and activities related to such trial.
- b. "Released Parties" refers (individually and collectively) to the Utah Stockdog Association, its invitees, owners, employees, volunteers, and all other representatives or agents the Utah Stockdog Association ("USA" or "Association"), and the property owner of the trial location, (collectively, "Released Parties").

2. ASSUMPTION OF RISK: Participation the Activity carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary from one activity to another, but the risks range from minor injuries to serious injuries or death. There are also unanticipated risks that could result in damage to livestock or property, to my dog, to dogs in my care, to other dogs, or to third parties. Risks to me also include dangers, both known and unknown, resulting from weather, spectators, exposure to infectious disease, other participants, facilities, staff, terrain, dogs, and livestock. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the Event.

I know, understand, and appreciate these and other risks that are inherent in The Activity. I hereby assert that my participation is voluntary and that I knowingly assume all such risks.

- 3. WAIVER AND RELEASE OF LIABILITY: In conjunction with my participation in the Activity, I release, waive, discharge, and covenant not to sue the Released Parties from any and all liability, claims, demands, actions, and causes of action whatsoever, arising out of or relating to any loss, or expense (including court costs and reasonable attorney fees) of any kind or nature which arises out of or results from my participation in the Activity, including claims for liability caused in part by the negligent acts or omissions of the Released Parties.
- 4. ACKNOWLEDGEMENT AND UNDERSTANDING: I have read this waiver of liability and assumption of risk, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue. I acknowledge that I am signing the agreement freely and voluntarily, and intend by my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.
- 5. I agree that I am responsible for any cost incurred as a result of damages caused by me, my family, my dog or dogs under my care or control to facilities, animals or persons.

Probable class order (although *this may change depending on entries!*):

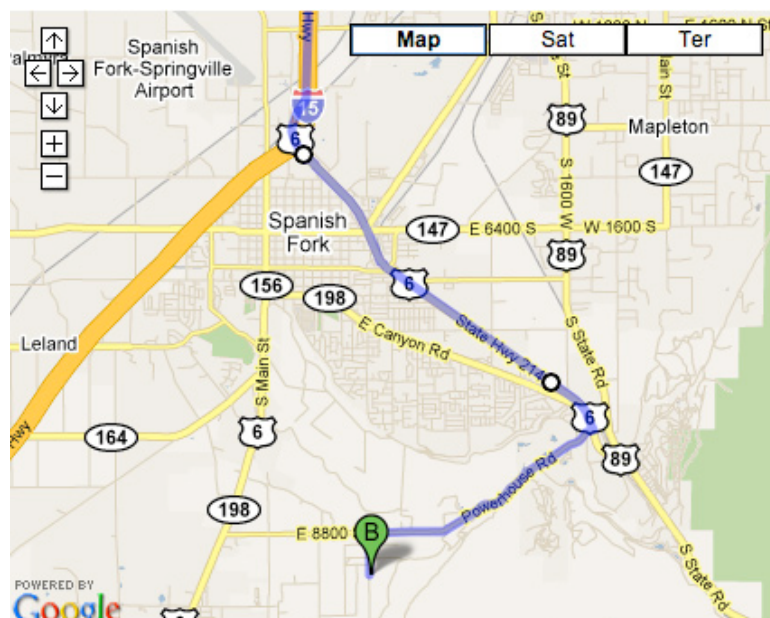
Open: Friday, Saturday and Sunday; Nursery may follow Open on Sunday. if there is time.

PN: Monday – both runs

Nursery: 2 runs on Monday; may be with PN run

Covid Requirements/ Guidelines

Utah County has one of the highest infection rates in Utah. Nonetheless, the County is classified as low risk and allows private gatherings up to 50 people. The following guidelines will be followed at the trial

- Face coverings must be worn where social distancing is difficult to maintain – that means you must wear a face covering any time that you are closer than 6' to others at the trial except for your household unit that you traveled with.
- Portable Toilets:
 - Those with RVs are not permitted to use the portable toilets unless it is an absolute emergency. Limiting use reduces the number of portable toilets needed and minimizes the risk of spread of infection. If you want to order a portable toilet, the cost will be approximately \$100 and you need to let me know by Oct. 20.
 - We will provide hand sanitizer at all portable toilets, but you are asked to bring your own in the event that we do not have sufficient supplies.
 - There will be one portable toilet reserved solely for the use of the judge and the scribe and course director on duty. There will be one portable toilet reserved for those working at set-out.
 - We will provide water and soap in the in-field area as close to the portable toilets as possible.
 - Face masks are **required** when you use a portable toilet
- There will be no food concession of any kind – all participants must furnish their own food.
- Handlers – please bring no more than one guest with you – we need to keep the numbers down. We will not have spectators other than handler guests.
